227.001 - [Code adopted.]

Sec. 1. That a certain document designated at the 2015 International Property Maintenance Code as published by the International Code Council, Inc., be and is hereby adopted as the 2015 International Property Maintenance Code of the Township of Atlas, in the State of Michigan; for the control of buildings and structures as herein provided; and each and all of the regulations, provisions, penalties, conditions and terms of said International Property Maintenance Code are hereby referred to, adopted, and made a part hereof, as if fully set out in the ordinance, with the additions, insertions, deletions and changes, if any, prescribed in Section 2 [227.002] of this ordinance. <u>Sec. 2</u>. The following sections are hereby revised:

Section 101.1 insert: Township of Atlas

106.3 Prosecution of violation. Any person failing to comply with a notice of violation or order served in accordance with Section 107 shall be deemed to have committed a municipal civil infraction as determined by the local municipality, and the violation shall be deemed a strict liability offense. If the notice of violation is not complied with, the code official shall institute the appropriate proceeding at law or in equity to restrain, correct or abate such violation, or to require the removal or termination of the unlawful occupancy of the structure in violation of the provisions of this code or of the order or direction made pursuant thereto. Any action taken by the authority having jurisdiction on such premises shall be charged against the real estate upon which the structure is located and shall be a lien upon such real estate. Violation of this ordinance is a municipal civil infraction.
